About USADA

The U.S. Anti-Doping Agency is the national anti-doping organization for the Olympic movement in the United States. The U.S. Congress recognized USADA as "the official anti-doping agency for Olympic, Pan American and Paralympic sport in the United States."

Since its inception in 2000, USADA has worked to preserve the integrity of competition, inspire true sport and protect the rights of athletes in the Olympic & Paralympic Movements in the United States. With the vision to be the guardian of the values and life lessons learned through true sport, our organization's anti-doping programs are comprehensive, including in-competition and out-of-competition testing, results management and adjudication processes, drug reference resources and therapeutic use exemption process, scientific research initiatives, and athlete and outreach education. We continue to work to improve our system and anti-doping endeavors to further protect clean athletes and the health of future athletes.

As a non-profit, non-governmental agency, our programs:

- Provide deterrence and preservation of sport for athletes, coaches, students, teachers, parents, scientists and more through education and resources;
- Include numerous protections for athletes to ensure that only athletes who are guilty of a doping violation are sanctioned;
- Strive to systematically identify and sanction those individuals who are engaged in the effort to gain an advantage over athletes who are competing clean; and
- Fund pioneering research for the detection of doping substances and techniques, and the pursuit of scientific excellence in doping control.

PARTNERSHIP FOR CLEAN COMPETITION

The Partnership for Clean Competition is a grant making, research-focused organization that was founded in 2008 by the U.S. Olympic Committee, Major League Baseball, the National Football League and the U.S. Anti-Doping Agency to support anti-doping research and the advancement of science underlying anti-doping technology.

MISSION

To protect the integrity of sport and public health by engaging and supporting the world's top scientists and innovators in high-quality anti-doping research and development.

VISION

To help generate the world's most influential, effective and coveted methods and resources for detecting and deterring the use of performance enhancing substances by all athletes in all sports at all levels, thereby demonstrating the value of science, collaboration and innovation related to doping control in sport and ensuring the benefits of sport participation worldwide.

As a 501(c)(3) non-profit and tax-exempt public charity, PCC is overseen by a board of governors comprised of representatives of the four founding organizations and has a standing volunteer scientific advisory board made up of eight internationally respected scientists with experience related to anti-doping. PCC is supported financially by the four founding partner organizations, and it receives and/or has received additional financial support from the National Hockey League, the PGA Tour, the National Collegiate Athletic Association and the National Basketball Association.

PCC's organizational business strategy and daily operations are overseen by the executive director. PCC's research agenda, grant requests and funding recommendations are guided by the SAB. The board of governors is responsible for final approvals related to grant funding. The PCC currently has no employees other than the executive director, who has historically been a USOC employee. PCC has access to select resources made available by the founding organizations and currently contracts the services of the USOC's legal and accounting departments.

PCC serves as a common and neutral ground for individuals and organizations of all athletic performance levels and disciplines to demonstrate their commitment collectively to addressing doping's root causes and ultimately decreasing the use of performance-enhancing drugs by all participants in all sports at all levels of play. As the only anti-doping-focused entity in the world where research and grant-making are the foundation of the business and the focus of everyday activity, it is the only unifying and collaborative environment of its kind.
