IV. COMPETITION – Aaron/Yahya

- Schedule
 - July 21st is most recent version
 - Finals immediately following semifinals for the same event
 - No break if all coaches agree
- Practice Groups (see meet packet)
 - Flighted warm-up group = Zone you competed at
- Board Close Times
 - 5 minutes before start of competitions
 - National anthem at the start of each day
- Springboards
 - Inspected and approved by two separate companies
 - Replacement boards on site
- Saturday, July 31
 - If no one is at the venue at 7 PM we will close the pool early
- Tuesday, August 3
 - Will try to end earlier than 7 if possible
 - Scheduled warm-up time between events will be protected
- Hot tub closed
- Dryland
 - Mats placed around deck and in back room
 - No trampolines or boards
- Awards
 - Presented immediately after each final
 - Includes all 12 finalists

- 12 Neutral judges
- Coaches
 - Only coaches who requested to judge

- “Go” sign
- Failed Dives
 - Diving from the wrong platform height
 - 2 in one contest disqualifies diver from advancement/award
 - Can still complete contest
- Re-dive
 - Can only request under extenuating circumstances
 - Other events going on so can’t be due to “normal” distraction
