III. COVID – Aaron

- Testing at Hilton Indianapolis Hotel & Suites
 - Anyone who will be on deck
 - Must take test before receiving credential
 - [Scheduling link](#)
 - \$10 to park at hotel for testing
- 2nd on-site test scheduled when you advance to finals
 - Same location
 - June 9 for all divers and coaches who have already advanced to finals
 - June 10 for divers and coaches competing on the 9th
- Symptom Monitoring
 - First thing in the morning and when entering the venue

- Physical Distancing
 - Masks must be worn at all times except when actively diving
 - Maintain 6 feet from other whenever possible
 - 15 minutes within 24 hours = close sustained contact regardless of masks
- Do not go into the stands after your competition
 - Will result in forfeiture of credential
 - Divers and coaches can watch events from the far end of the pool deck
 - Must be 6 feet apart from others
 - Limits and/or closures will be enforced if physical distancing is not being adhered to
