All Coaches must present their USA Boxing Coach (red) passbook with attached 2021 membership ID card and photo in order to receive a credential to enter the Field of Play.

Host Hotel: The Hilton will serve as the event host hotel. ALL event functions will take place at the Shreveport Convention Center including competition, check-in, weigh-ins, coaches workout space, clinics, workshops and other meetings.
