Every Kid Sports

- USA Boxing will have a sponsor called “Every Kid Sports”
- This program will be offered for free to youth boxers (8-18) who receive any sort of government assistance program.
- This program will offer up to \$140 a quarter provided on a debit card that can only be spent with USA Boxing. This money will be used to join USA Boxing. We are also working on the remainder of that money being allowed to go to the athletes registered USA Boxing Gym to help offset some of those costs.
- We hope the program will serve about 4,000 members.
- There is no limit to the amount of youth boxers who can participate in this nationwide program.
- This is a great opportunity to remove financial barrier for kids to have the ability to compete.
- After launching the program, we will provide some townhall trainings for LBC registration chairs who have questions.

Membership Update from Lynette Smith, Membership Director

- November 1st started early registration. On the first day of registration USA Boxing had 500 members join.
- We are working on LBC directors and officer’s insurance with our new broker. We have a form to fill out and send back to us to apply for the D & O insurance.
- We have also worked with our insurance company to offer business insurance including fire and property. Information will go out next week, there will be a link so the clubs can sign up. This will be offered directly from the insurance company.

National Championships and Events update from Mike Campbell, Events and Operations Director

- Please have your boxers register as soon as possible as brackets are starting to fill up.
- Coaches’ registration is free until Thanksgiving. After that there will be a late fee imposed
- Please have all walk up officials also register online.
- Please keep up to date on the event page, most notably the check in schedule, Covid policy and spectator policy.
- We sent out a survey regarding Covid Vaccination. This data is useful when applying for grants or when talking with the USOPC about our athletes training on campus.
- We are very close on announcing the Junior Olympics host city. It will still be the 2nd or 3rd week of July.
- We are planning a spring tournament that will take place in late April.
- There will be no fall USA Boxing tournament.

Rulebook

- We are working with the R/J committee on minor revisions to the rulebook.
- New Rulebook will go into effect January 1, 2022 and will be sent to the COO’s for one last round of comments.
