**Welcome from Mike McAtee – Executive Director:**

- Thanked LBCs leaders for their great work.
- Opened with how successful the National Qualifier in Cleveland went.
- Updates on Junior Olympics and Summer Fest will be coming out within the next week.
- Heads up on a few things:
  - Tyson Lee was elected as the AMBC Vice President, which will help for more international possibilities.
  - IBA Elections are May 13<sup>th</sup> & 14<sup>th</sup>
    - There are 28 candidates running for 11 spots
    - IOC said IBA needs to make serious changes to ensure participation in the LA 2028 Olympics.
  - Boxing is set to be in Paris with 7 Male and 6 Female weight classes, but we have not been pre-approved for LA yet.
  - Changing of leadership will help show the IOC that IBA is committed to change.
  - High Performance update: After just leaving camp in Italy, the Women's team is on the way to Turkey for Women's Championships (Live Stream links will be sent out).
  - When it comes to compliances some LBCs have done a great job!
    - Pat Butler, LBC Rep and Treasurer, is pleased that 52 LBCs are in full compliance

    - There will be free LBC sanctions given out to LBCs who submitted paperwork on time.
    - If you are having troubles with finding doctors, please reach out so we can do our best to help.
  - Membership numbers are great:
    - The goal was 32,000 Athletes by the end of the year and we are already at 24,000.
    - We passed the Non-Athlete goal of 10,500

- In 2019 we had 2,043 gyms registered (the most we've ever had) and now we are over 2,000!
- If there is boxer in your gym, they MSUT be registered as a USAB Member to be covered by insurance.
  - If they cannot afford the registration fees, they can sign up as a "Fitness Member" and when they want to compete, they can change their membership and just pay the difference between the two different memberships.
  - **Elichi Jumawan (Hawaii)** suggested using insurance coverage in publicity to get gym attendees to join USA Boxing.

- There has been an increase of 3<sup>rd</sup> party sanctions, which is how it should be. Illinois LBC will tell you that the funds generated help the LBC.

    - Fact sheet will be sent out soon and registration opens May 10.
    - We are planning on the opening ceremonies and parade to take place Sunday, July 10.
    - Some LBCs are planning on having a Junior Olympic in their area which is awesome for the people who cannot make the trip out to Wichita.
