Dear USA Curling Athletes,

We hope that you and your loved ones are staying healthy. Thank you to those who joined in the Athlete Town Hall that took place on Monday (6/22). We appreciate the questions that were brought forward and hope to have more answers as USA Curling continues to work closely with [Dr. Finnoff](#) from the USOPC and [Dr. Cole](#), the National Team doctor from Twin Cities Orthopedics, to determine the safest path forward.

### **Return to Training**

Depending on where you are geographically located, gyms and training facilities may be reopening. If you are considering training in a gym or public facility, USA Curling asks that you first make sure the facility has procedures in place to best ensure your safety. For example, the [Training HAUS](#), the facility utilized by some National Team athletes, has cut down the number of individuals that are allowed in the facility at one time, is now requiring all athletes to take a health screening survey prior to entry, has moved as many training sessions as possible to outside or the larger area, and sanitizes all equipment between uses.
