Wear a Mask

Based on USA Curling's consultations with medical professionals such as the USOPC Chief Medical Officer, along with the recommendations of the CDC, USA Curling recommends that masks be worn when curling. COVID-19 is spread through respiratory droplets, thus making it imperative to minimize the transmission of these droplets to fellow curlers by wearing a cloth face covering, especially when competing. Safety Standards

USA Curling is working in conjunction with USOPC medical staff to establish health and safety standards that will be controlled and enforced at USA Curling hosted events. Once finalized, those procedures (and any subsequent updates) will be shared. USA Curling encourages event hosts to share what health measures are being taken at their specific events so that competitors can make better informed decisions regarding their attendance.

Schedule

As mentioned in the update from 6/26, USA Curling's coaching staff will revisit the schedule of tour events located within the United States on a weekly basis to ensure that any updates are provided with as much notice as possible. Even if unchanged, the schedule will be included in the weekly updates moving forward.
