

**United States Curling Association
2018 Honorary Team Captain Drawing**

The United States Curling Association is proud to sponsor a drawing to benefit the growth and development of curling in our country. For every donation of \$20 during this campaign, each donor will be entered into a drawing to win a trip to serve as Honorary Team Captain and support the U.S. Curling Team during the 2018 World Men's Curling Championship in Las Vegas, March 31 – April 8.

The 4-day, 3-night trip* for two includes:

- **Airfare (economy class) to/from the winner's home airport (must be a commercial airport location in the United States) and Las Vegas**
- **Three night's hotel at The Orleans Hotel & Casino, double occupancy, (room limited to two people)**
- **Ground transfers to and from the Las Vegas airport to The Orleans**
- **Tickets to each day's curling competition**
- **Official U.S. Curling Team apparel and pins**
- **VIP experience with the teams**

Winner will be chosen by midnight CST, February 16, 2018, and notified by February 20, 2018. The estimated value of this package is approximately \$5,000.

***The winners will choose a consecutive three-night, four-day period from March 31 through April 8, 2018.**

TERMS AND CONDITIONS

Air and Ground Transportation, Hotel and Games Tickets package (approximate value - \$5,000.00) will include the following:

- **Roundtrip economy class airfare from the winner's hometown airport (must be a commercial airport location in the United States) to Las Vegas, Nevada**
- **Three night's hotel at The Orleans Hotel & Casino, double occupancy, (room limited to two people)**
