1. 1.Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.
1. 2.Agree that prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor and/or a tournament official of such condition(s) and refuse to participate.
