### **How to Request a Certificate of Insurance**

Should a club (in good standing) need a certificate of liability insurance, the USARS application 2018 Roller Sports Contest Insurance Application, must be filled out completely and submitted to the USARS National Office. A club may request a certificate for the membership season (referred to as a blanket certificate) if the facility is a USARS charter location or for a single event if the event is sanctioned by USARS. Applications are due 14 days prior to the event date. If there is a contract between the club and the venue, a complete and signed copy must be submitted with the application. Please note that the USARS membership season coordinates with the calendar year.
