General Requirements:

- Selected team **apprentice** staff position applicants must have passed a background check via the National Center for Safety Initiatives.
- Selected team **apprentice** staff position applicants must take and pass Safe Sports Certification.
- All **apprentice team** staff members must hold current membership in USA Roller Sports.
- Team **apprentice** staff members must be available to travel with the team to and from the event.
- A resume of sporting experience must be submitted with this application.
- Applicant must agree to Abide by the USOPC Code of Ethics
- Applicant must be able to work well with others and take and follow through on given directions from the 2020 USARS World Team Staff.
- Applicant must be flexible and available for athletes needs while at the World Championships 24 hours a day.
- Applicant must work well under pressure.
- Prior international travel with the sport and/or coaching experience at the International level is a must.

Additional Sports Specific Requirements and Responsibilities:

- **Apprentice** Coaches must be recognized and current as a USARS Advanced Coach or Elite Coach
- **Apprentice** Managers are not required to be USARS members before applying but if selected are required to become USARS members, however, they will be required to take a background check via the National Center for Safety Initiatives and complete the SAFE SPORTS CERTIFICATION program.

Considerations:

- Gender Representation - An effort will be made to include female staff members for all female teams: male staff member representation for male teams, and both male and female staff members for mixed gender teams. This consideration also applies to apprentice staff positions.
- Ability to work well with elite athletes, their parents and personal coaches, as well as other staff members and in high-pressure situations
- Support of USA Roller Sports programs domestically through involvement
- Preference may be given to demonstrated international experience
- Consideration may be given to the applicant's status with potential World Team members, either as personal coach or family member.

Selection Procedure:

The Speed Skating Committee shall review the **apprentice** applications received by the designated deadline. An interview will be conducted and the Speed Committee will provide their recommendations for the positions of 2020 USA Team **Apprentice** staff to the USARS Executive Committee for final approval.

By my signature below, I hereby acknowledge that I have reviewed the USA Team Staff Responsibilities and if selected will complete them to the best of my ability.

I further agree to abide by the rules of USA Roller Sports, World Skate (previously known as the Federation Internationale de Roller Sports) and the United States Olympic and Paralympic Committee. I understand that as a member of the USA Team Staff, I represent our sport and the USA and will conduct myself accordingly both during the competitions and any time while I am present at the event city in accordance with the USOPC and USARS Code of Ethics.

Selection as a member of the USA Team Staff is a privilege, and I am aware that inappropriate conduct may result in forfeiture of this privilege and dismissal from the Team Staff.
