Liability Coverage Highlights

Commercial General Liability Policy will pay amounts up to the policy limit that the insured is legally obligated to pay as damages for covered bodily injury, personal injury or property damage and advertising injury, subject to policy terms and conditions. The property damage or bodily injury must have occurred during a covered activity. The insurance company will defend suits against the insured alleging damages for bodily injury, personal injury or property damage that falls under the scope of the policy.

Certificates of Insurance

Certificates of Insurance are issued as proof of insurance coverage to a third party or certificate holder, such as a landowner, park district, recreation facility, high school, boys and girls club, or government entity. If required, the certificate holder may be named as an Additional Insured on the liability policy.

If your club requires a certificate of insurance please complete the Certificate of Insurance Request Form and return it to USA Table Tennis.

Administration

If you are served with a summons and complaint or involved with any litigation you must contact USA Table Tennis immediately. All incidents, no matter how minor, should be reported.

Covered Activities:

While participating as a member in scheduled, sponsored and supervised activities, events or practices of the Policyholder. This includes supervised group travel directly and uninterruptedly to or from scheduled events. Coverage applies to all registered members of USATT against accidental death, dismemberment and provides excess medical benefits as follows:

Benefit Schedule:

- Accidental Death Benefit \$ 15,000
- Accident Medical Benefit \$ 25,000
- Benefit Period 156 weeks from date of the injury
- First Covered Expenses must be incurred within 60 days from date of injury
- Deductible: \$ 500.00 per accident
- All accident medical claims are excess of any other valid and collectible insurance and each accident must meet the \$ 500 deductible.
