PLEASE READ THOROUGHLY AND PROVIDE YOUR SIGNATURE

1. IN CONSIDERATION of being permitted to participate in any way in USA Table Tennis sanctioned events, I and/or my minor child, our personal representatives, assigns, heirs, and next of kin:
2. ACKNOWLEDGE, agree, and represent that I and/or my minor child understand the nature of Table Tennis Activities and that I and/or my minor child are qualified, in good health, and in proper physical condition to participate in such Activity. I further agree that if at any time I believe conditions or equipment to be unsafe, I and/ or my minor child will immediately discontinue further participation in the Activity.
3. FULLY UNDERSTAND that (a) TABLE TENNIS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, DISMEMBERMENT, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by me and/or my minor child's own actions, or inaction, or the actions or inaction of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISKS AND SEVERE SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I and/or my minor child incur as a result of my participation in the Activity.
4. HEREBY ACCEPT AND ASSUME ALL SUCH RISKS, KNOWN AND UNKNOWN, AND ASSUME ALL RESPONSIBILITY FOR THE LOSSES, COSTS, AND/ OR DAMAGES FOLLOWING SUCH INJURY, DISABILITY, PARALYSIS, OR DEATH, EVEN IF CAUSED, IN WHOLE OR IN PART, BY THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW.
5. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE USA TABLE TENNIS, their respective administrators, directors, agents, officers, officials, volunteers, and employees, other participants, any sponsors, advertisers, and if applicable, owners and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS; AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT I and/or my minor child, or anyone on my and/or my minor child's behalf, makes a claim against any of the Releases, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.

7. By registering for the 2019 US Open Table Tennis Championships, all participants are subject to possible selection for drug testing as conducted by the US Anti-Doping Agency.
8. MEDICAL AND TRANSPORTATION RELEASE – I hereby give consent for the organizers of the 2019 US Open Table Tennis Championships to provide me with an athletic trainer and emergency medical treatment. This release is effective for the period of December 16 - 20, 2019. I swear and affirm that I am in good physical condition and I am not aware of any previous or existing diseases or injury that would result in my being injured. I further acknowledge that I have procured on my own and currently hold valid and adequate insurance for such loss, damage, or injury and if I do not have valid and adequate insurance, I accept full responsibility for the cost of the loss, damage, or injury that might occur as a result of my participation in the 2019 US Open Table Tennis Championships. I give my consent to participate in any and all emergency transportation associated with activities during the 2019 US Open Table Tennis Championships, in the event I become incapacitated or otherwise not conscious to give direct consent and I accept full responsibility for all costs associated with all emergency transportation as deemed necessary. Further, as the parent/guardian of a participating minor athlete, I hereby give my consent for complete medical treatment and emergency transportation services as deemed necessary beyond the on-site athletic trainer or emergency medical treatment provided.

Rules: The 2019 U.S. Open Table Tennis Championships will be conducted under the ITTF Rules.

If an umpire is available, a certified umpire will be assigned by the chief umpire at the request of any player in a match.

Call for Umpires: USATT is asking players who are umpires to volunteer to umpire at the US Open Table Tennis Championships. The umpire must be available for a block of four hours or more. Please contact: Roman Tinyszyn (iuroman@comcast.net).

Membership: USATT Memberships must be valid through December 17, 2019. Non-members or expired memberships must enclose membership fee with their entry forms or purchase a one-time Tournament Pass for \$25.

Matches: All matches will be best three out of five games to eleven, unless otherwise specified.

Event Scheduling: Events are not guaranteed to be completed on the same day that they begin.

No refunds will be given for early departure. All events will be completed by Saturday (December 21, 2019) evening. Any event may be cancelled if the event contains less than four players or pairs, as appropriate. (For Event Fee Participants, the cost of an event cancelled for lack of appropriate numbers of participants will be refunded.) In the case of event conflicts, the player is responsible for notifying the Control Desk as soon as possible. In case of an inadvertent error, liability is limited to the refund of the event fee for the event(s) involved. Each event will begin on the date/time designated on the form, and it will continue at regular intervals until a champion has been determined. Clothing: White shirts, shorts and skirts will not be allowed. Players must wear either their assigned number or their name on the back of their shirt when competing. However, in cases where the default is due to illness or injury, an athlete may appeal to the Tournament Director for the right to be permitted to participate in a separate Youth and/or Men's or Women's Championship Event for which the athlete has previously registered other than the Event in which the athlete defaulted. The Tournament Director is vested with the sole authority, without opportunity for appeal, to determine whether the athlete's default was due to a verifiable injury or illness and whether said athlete should be permitted to compete in a said separate Event.

Age Events:

Hopes—Must be born on or after January 1, 2007

Minicadets—Must be born on or after January 1, 2006

Cadet Events— Must be born on or after January 1, 2004

Junior Events—Must be born on or after January 1, 2001

Under 21—Must be born on or after January 1, 1998

Other Age Events—Must be 30 or over, 40 or over, 50 or over, 55 or over, 60 or over, or 70 or over as of December 31, 2019. For Team Age Events, all players on the team must qualify on the age restrictions for the team event. Proof of age must be readily available at the tournament. Players assume the responsibility of entering the appropriate age events. Players who are over/under the age limit of an event will automatically be entered in the correct age event.

Rating Events

Rating Restrictions and Seeding: For rating eligibility (qualification), the ratings list as of 10/17/2019 will be used. This can be found on the rating page at www.USATT.org or by email to Ethan.Figge@usatt.org. For draw and seeding purposes, the most recent USATT rating list as of 11/29/2019 will be used. Players that are over the rating limit of an event will automatically be entered in the next event. Players may obtain their ratings by contacting USA Table Tennis via email at Ethan.Figge@usatt.org. As a result of later seeding, some players may have ratings higher than shown for the event.

Unrated Players: players without USATT rating: Players may enter any championship event for which they are otherwise eligible. Players who are unrated on the seeding date (11/29/19) will not advance to the single elimination stage of rating-restricted RR events. Players who enter a rating-restricted event without a rating and who acquire a rating between the qualification cutoff (10/17/2019) and the seeding (11/29/2019) will be permitted to advance provided their new rating meets the event's requirements. Unrated players are not permitted to enter rating-restricted single elimination events.

RATING DOUBLES EVENTS: Players MUST be rated under 2600 to participate in the U4500 Doubles; under 2300 to participate in U3800 Doubles; and under 2100 to participate in the U3100 Doubles.

Rating Adult and Junior Events: Players entering the Rating Junior events must be born on or after 1/1/2001 (18 and under). Players entering the Rating Adult events must be born on or before 12/31/2000 (19 and over).

PLAYING FORMATS:

Men's and Women's Singles Championship Events: For the purposes of seeding, ITTF Rankings as of November 29, 2019 will be used. All matches in the main draw and qualification will be 4 out of 7 games.

U21 Men's and Women's Singles: Participants must be born on or after January 1, 1998. For the purposes of seeding, ITTF Rankings as of November 29, 2019 will be used. Matches will be 3 out of 5 games in qualification rounds, and 4 out of 7 games in the main draw.

Men's, Women's and Mixed Doubles: For the purposes of seeding, ITTF Rankings as of November 29, 2019 will be used. Matches will be 3 out of 5 games in qualification rounds, and 4 out of 7 games in the main draw.

Teams: Corbillon Cup System: 4 singles and 1 doubles. A-X, B-Y, doubles, A-Y, B-X Playing system will be Single Elimination or Round Robin depending on number of entries. There can be a maximum of three members on each team.

Doubles Partners: Players MUST enter with a partner in all doubles events. USA Table Tennis will NOT arrange for a doubles partner. USATT cannot be responsible for the nonparticipation of your selected Doubles Partner. It is the responsibility of the players to contact his/her doubles partner about participating in the event. Players without a rating at the Qualification time can't enter rating doubles events. Partners withdrawing before November 15, 2019, may be replaced provided the replacement partner has a lower rating than the original partner, partners withdrawing after November 15, 2019, may not be replaced. If you have not found a doubles partner as of December 1, 2019, you will be dropped from the event.

Hardbat Event: This event will follow the hardbat rules adopted by the USATT Classic Table Tennis Committee found at www.hardbat.com. Rackets must comply with the rules found on www.hardbat.com. This event will not count for USATT rating points. Seeding will be based on hardbat ratings, or USATT ratings for players who do not have hardbat ratings. Matches will be best 2 out of 3 games to 21 except for the quarterfinals, semifinals and finals, which will be best 3 out of 5 games. Ball: Nittaku Premium 40+, White.

Sandpaper Event: This event will follow the hardbat rules, except that rackets must be wooden blades with sandpaper playing surfaces. Matches will be best 2 out of 3 games to 21 except for the quarterfinals, semifinals and finals, which will be best 3 out of 5 games. Ball: Nittaku 38mm, Orange.
