



## 2022 FISU WORLD UNIVERSITY CHAMPIONSHIPS TEAM SELECTION CRITERIA

### 1. Introduction

This 2022 FISU World University Championships Team Selection Criteria (the “Criteria”) will be used to determine the athletes that will represent the United States at the 2022 International University Sports Federation (FISU) World University Championships (the “Team”) in **Maceio, Brazil**, on or about **September 10-12, 2022** (the “World Championship”). These selection criteria are designed to provide emerging college elite athletes who meet FISU age and academic eligibility requirements the opportunity to continue their development in international triathlon competition.

Under FISU World University Championships (the “Championships”) eligibility guidelines (<http://www.fisu.net/en/FISU-Triathlon-3582.html>) the United States may enter a maximum of six (6) men and six (6) women to compete in the Championship. USAT intends to nominate and support a Team of four (4) men and four (4) women to this event. Self-nominated participants above this would be subject to all travel and participation costs. While holding a USAT Elite License is not a requirement for selection, athletes are advised that elite international draft-legal racing experience is highly determinative of success at the FISU World Championships.

USAT will make selections to the Mixed Relay event in accordance with the USAT Mixed Relay Event Selection Criteria.

Athletes are advised that entry into the Championship does not follow the traditional World Triathlon nomination timeline and that athletes seeking selection will be required to complete eligibility forms and obtain certification from their college or university in advance of the selection deadlines.

### 2. Minimum eligibility requirements for an athlete to be considered for nomination to the Team:

- a. Athlete must be eligible under all applicable rules of FISU ([www.fisu.net](http://www.fisu.net)), World Triathlon ([www.triathlon.org](http://www.triathlon.org)), the U.S. Anti-Doping Agency ([www.usada.org](http://www.usada.org)), and USA Triathlon.
- b. Athlete must be a current annual member in good standing of USA Triathlon.
- c. Athlete must be able to obtain certification from their college or university in accordance with FISU rules.

### 3. Selection Events

- a. **Selection Event #1:** 2022 Americas Triathlon Cup, Long Beach, July 16-17, 2022.
- b. **2022 World Triathlon Points:** World Triathlon Ranking Points earned between March 12 & July 18, 2022.
- c. **World Triathlon Ranking:** World Triathlon Ranking as of July 18, 2022.

### 4. Selection Procedure

- a. The maximum team size for the Team is expected to be six (6) athletes per gender, however, USAT intends to nominate and support a team of four (4) men and (4) women. Should athletes self-nominate to participate in the 5<sup>th</sup> and 6<sup>th</sup> team spot, USAT will prioritize their entries based on World Ranking Points earned in 2022 as of July 18, 2022. Self-nominations must be submitted to USAT by emailing [wtentries@usatriathlon.org](mailto:wtentries@usatriathlon.org) no later than July 18, 2022.

- b. **Automatic Selection:** (to be selected in order below)
  - i. The two (2) highest placing FISU-eligible USA athletes at **Selection Event #1** will automatically qualify for the Team provided they finish among the Top 12 overall and within five percent (5%) of the winner's time.
  - ii. Remaining quota spots will be allocated according to World Triathlon points in two ways.
    - o One (1) spot will be awarded to the athlete having earned the highest total number of **World Triathlon Points** between March 12, 2022 and July 18, 2022, who has not already been selected.
    - o One (1) spot will be awarded to the athletes possessing the highest **World Triathlon Ranking** current as of July 18, 2022, who have not already been selected.
- c. **Discretionary Selection:** USAT will fill all spots not earned by achieving Automatic Selection per the Discretionary Selection process described below up to the expected full quota (normally six (6) men and six (6) women).
- d. **Cancellation or Modification:** In the event of cancellation of any portion of the selection event (swim, bike or run), spots will be filled at USAT's discretion. If the distance of any leg of the event or the entire event is shortened by more than 50%, the spots will be filled at USAT's discretion.

## 5. Discretionary Selection

- a. Rationale for utilizing discretionary selection: By meeting the automatic selection standards, athletes will have demonstrated their ability as the best USA athletes in this category. If the maximum number of USA athletes has not met the standards for automatic selection, then USA Triathlon may select athletes who, in the opinion of the International Competition Panel (ICP), can win a medal despite not performing to the standard at the Selection Events, or who can contribute to winning a Mixed Relay at the Championship.
- b. Discretionary Process: Any athlete who meets the minimum eligibility requirements in Section 2 may be considered for nomination. The Selection Committee shall rank athletes for nomination to FISU. USAT will submit all approved entries to FISU by its registration deadline. Athletes will be notified of their selection on or before that date.
- c. Discretionary criteria:
  - i. The following criteria shall be used for discretionary selection. The criteria are listed in no particular order:
    - 1. Finish place in the Selection Events;
    - 2. World Triathlon Points List ranking; and/or,
    - 3. Performance measures at the Selection Committee's discretion.
- d. The ICP will be responsible for discretionary selection and will be comprised of two (2) members of the High Performance Department staff and one (1) Elite Athlete representative.

## 6. Removal from the Team

- a. An athlete who is to be nominated to the Team by USA Triathlon may be removed as a nominee for any of the following reasons, as determined by USA Triathlon:
  - i. Voluntary withdrawal. Athlete must submit a written letter to the USA Triathlon High Performance Development Manager.
  - ii. Injury or illness as certified by an USA Triathlon-approved physician (or medical staff). If an athlete refuses verification of his/her illness or injury by an USA Triathlon-approved physician (or medical staff), his/her injury will be assumed to be disabling and he/she may be removed.

- iii. Violation of the USA Triathlon Code of Conduct. An athlete who is removed from the Team pursuant to this provision has the right to a hearing per the USA Triathlon Bylaws Article XV or the USOC's Bylaws, Section 9.

## 7. Replacements to the Team

- a. If for any reason a position on the Team shall become vacant, such vacancy shall be filled according to the discretionary criteria above, provided that the replacement athlete meets all applicable eligibility criteria, and a replacement is allowed by FISU. In the event that no athlete meets all of the eligibility and discretion selection criteria, or FISU does not allow replacement, the vacancy shall not be filled. At the discretion of the Selection Committee, a vacant funded quota spot may be filled by an athlete who self-nominated and was selected to fill the 5<sup>th</sup> or 6<sup>th</sup> position on the team, whereby the 5<sup>th</sup> or 6<sup>th</sup> position would then be filled based on the World Triathlon Ranking Points Ranking available at the time of the replacement.

## 8. Additional Requirements for Selection

- a. All athletes selected to the Team will be required to comply with all applicable rules and requirements of World Triathlon, FISU, WADA, USADA, and USAT, including, but not limited to, the following:
  - i. Abide by the USAT's Code of Conduct, any USAT or World Triathlon Waiver or Release, and conform to all USAT policies and protocol regarding Team preparation and participation.
  - ii. Agree not to race any event **longer** than the standard triathlon distance (1.5km/40km/10km) up to six (6) weeks prior to the date of the World Championship.
  - iii. Agree to stay in lodging as a team for the Championship. All travel and accommodation arrangements will be coordinated by the High Performance staff.
  - iv. Agree to participate in all FISU pre- and post-race events, including opening and closing ceremonies.
  - v. **Athletes must comply with ITU Competition Rule 2.4(c), requiring an electrocardiogram (ECG) and pre-participation evaluation (PPE) in order to participate in certain ITU officiated events. Satisfaction of these requirements will be a condition of nomination to participate in this championship.**
  - vi. Athletes who wish to compete in Junior, U23, FISU, Elite, and Paratriathlon categories at World Triathlon events are required to complete and pass the USAT Safe Sport tutorial. More information about how to access the tutorial can be found at [www.usatriathlon.org](http://www.usatriathlon.org). This tutorial needs to be completed annually.   - vii. Athlete must be eligible to enter and compete in the country at which the event is held. This includes, but is not limited to having an acceptable visa, passport and meeting all country health evidentiary requirements.

## 9. Team Athlete Benefits (Funded Athletes only)

- a. USAT will provide staff and/or experienced contractors to serve as Team Leader(s) for this event.
- b. USAT will look for opportunities to decrease the total cost of the trip to World Championships for those attending by subsidizing lodging, transport, and/or competition fees as possible.
- c. USAT will inform qualified athletes their expected costs involved with this competition trip upon selection.

- d. USAT will provide an approved team uniform.
- e. USAT will pay the FISU and any World Triathlon entry fees.
- f. Self-nominated athletes will be responsible for all participation costs.

#### 10. Withdrawal Penalties

- a. *Withdrawal deadlines:* the World Triathlon withdrawal deadline is 30 days prior to the first competition day in the event program; ***the USA Triathlon withdrawal deadline is 31 days prior to the first competition day in the event program (this is the day after the start list is produced)***. If an athlete fails to remove himself or herself from an event by the USA Triathlon withdrawal deadline, then a penalty will apply.
- b. *Penalties:* If a withdrawal is requested within 31 days of the event (the day after the start list is produced), USA Triathlon will impose the penalties outlined below. In exceptional circumstances (e.g., a new and verified medical impairment or verified extenuating circumstance) penalties may be waived. For this to occur, an athlete must submit a written explanation of their situation with relevant supporting documentation to [wentries@usatriathlon.org](mailto:wentries@usatriathlon.org). A discretionary panel, with at least 20% athlete representation, will be formed to review the materials and determine if the situation warrants a waiver of the penalty.
  - i. **1<sup>st</sup> offense:** \$250 fine
  - ii. **2<sup>nd</sup> offense:** \$500 fine
  - iii. **3<sup>rd</sup> offense:** \$1000 fine and ineligible for any World Triathlon event starts for 3 months from the corresponding event date

#### 11. International Disclaimer

- a. These Selection Criteria are based on the latest information available to USAT, and on World Triathlon, FISU and USAT rules and regulations as presently known and understood. Any change in the selection procedures caused by a change in World Triathlon, FISU or USAT rules and regulations, or other unforeseen circumstances, will be distributed to the affected athletes promptly, and USAT reserves the right to revise these Selection criteria in such event.
