### Expected Games Selection Timeline:

#### **2022**

**March 8, 2022** – Timeline, process and 2024 Olympic Games Selection Procedures Task Force established. (Steps 1-3)

**March 15, 2022** – 2024 Olympic Games Selection Procedures Task Force convenes to begin its work

**May 1, 2022** – Initial 2024 Olympic Games Selection Procedures Guiding Principles shared with stakeholders for comments and feedback

**June 15, 2022** – USAT Senior Counsel drafts initial 2024 Olympic Games Selection Procedures based on Guiding Principles and feedback from athletes and AAC representatives.

**July 15, 2022\*** – HP leadership and Senior Counsel circulate draft of initial Games Selection Procedures and solicit feedback from the AAC and other elite athletes *\*Contingent upon World Triathlon Olympic Games Qualification System being finalized.*

**August 15, 2022** – USAT Senior Counsel incorporates revisions to the 2024 Olympic Games Selection Procedures as necessary

**September 15, 2022** – USAT communicates and publishes the final version of the 2024 Olympic Games Selection Procedures

#### **2023**

**February 2023** –HP leadership to solicit feedback from the AAC and other elite athletes regarding the 2024 Olympic Games Long List criteria and 2024 Olympic Games Staff Selection Procedures

**December 2023** – After consultation with the AAC and opportunity for input from athletes, USAT will name the 2024 Olympic Games Selection Panel

#### **2024**

**June 2024** – 2024 Olympic Games athlete selection expected to be completed and communicated
