In order to be eligible to run and/or vote for Athlete Director position, athletes must be international athletes as defined in the USAV bylaws. Eligible athletes must either:

Have represented the United States in Olympic Games, Pan American Games or an Operation Gold competition (as defined by the USOC) within the preceding ten (10) years as determined at the time of the election (March 14, 2014), and/or

Within the twenty-four (24) months before the election (March 14, 2014), have demonstrated as being “actively engaged” in the sport of beach volleyball. “Actively engaged” is defined as during the period between March 2012 – March 2014 being a member of the Beach National Team (athletes ranked top 8 per gender according to the FIVB Technical Ranking at any time during the 10-month season who meet the Beach National Program minimum criteria) or A2 Beach National Team (athletes with 400 or more FIVB Technical Ranking points (at any time during the 10-month season) not ranked in the top 8 per gender and who meet the Beach National Program minimum criteria.
