Resolution of Disputes

- The USOC must provide for the swift resolution of conflicts and disputes involving amateur athletes, national governing bodies, and amateur sports organizations.  
[TSOASA §220503 (8)] pg 93
- The USOC must protect the opportunity of any amateur athlete, coach, trainer, manager, administrator, or official to participate in amateur athletic competition.  
[TSOASA §220503 (8)] pg 93
- The USOC shall establish and maintain provisions in its bylaws for the swift and equitable resolution of disputes involving any of its members and relating to the opportunity of an amateur athlete, coach, trainer, manager, administrator, or official to participate in the Olympic Games, the Paralympic Games, the Pan-American Games, world championship competition, or other protected competition as defined in the bylaws of the USOC.

- NGB must provide procedures for the prompt and equitable resolution of the grievances of its members.

- No NGB or other member of the USOC may deny or threaten to deny any amateur athlete the opportunity to participate in the Olympic Games, the Pan American Games, the Paralympic Games, a World Championship competition, or other such protected competition.

- "protected competition" means any amateur athletic competition between any athlete or athletes officially designated by the appropriate NGB as representing the United States, either individually or as part of a team, and any athlete or athletes representing any foreign country...

- The USOC shall, by all reasonable means, protect the opportunity of an amateur athlete to participate if selected (or to attempt to qualify for selection to participate) as an athlete representing the United States.

- If an impending competition requires immediate resolution of the complaint, an athlete may file a claim with the AAA simultaneously with the filing of the complaint with the USOC CEO. [USOC Bylaws, Section 9.7] pg 40
- If an expedited hearing is necessary, the AAA shall hear and decide the claim within forty-eight (48) hours of the filing of the claim under procedures that are fair to all parties. [USOC Bylaws, Section 9.9] pg 40
- Athlete is entitled to a reasoned award after a AAA hearing [USOC Bylaws, Section 9.7] pg 40
- If you are an athlete who is potentially adversely affected by a AAA hearing of the complaint of another athlete, you are entitled to participate in the AAA hearing as an affected party. [USOC Bylaws, Section 9.7] pg 40
- No claim previously adjudicated by an anti-doping agency may be brought by the athlete under Section 9. [USOC Bylaws, Section 9.11] pg 41
- Field of play decisions generally are not subject to Section 9 complaints. [USOC Bylaws, Section 9.12] pg 41
- Action under Section 9 does not bar an athlete from bringing a claim under Section 10. [USOC Bylaws, Section 9.13] pg 41
- Any reference to athlete in Section 9 of the USOC Bylaws shall also equally apply to any coach, trainer, manager, administrator or other official. [USOC Bylaws, Section 9.1] pg 39
- A claim must be filed with the AAA within at six (6) months of the alleged date of denial [USOC Bylaws, Section 9.10] pg 40

#### Participation in the NGB and its Governance

- NGB with membership open to any individual who is an amateur athlete, coach, trainer, manager, administrator, or official active in the sport for which recognition is sought. [TSOASA, §220522, (a)(7)] pg 103
- No eligibility criteria related to amateur status or to participation in the Olympic Games, the Paralympic Games, or the Pan-American Games that are more restrictive than those of the

appropriate international sports federation.

#### IOC Rules re: Entry into the Games

- The practice of sport is a human right.  
[Fundamental Principles of Olympism] pg 10
- Any entry is subject to acceptance by the IOC, which may at its discretion, at any time, refuse any entry, without indication of grounds. Nobody is entitled as of right to participate in the Olympic Games.  
[Rule 44, 3.] pg 77
- The USOC must investigate the validity of the entries proposed by NGBs and ensure that no one has been excluded for racial, religious or political reasons or by reason of other forms of discrimination.

- The USOC shall send to the Olympic Games only those competitors adequately prepared for high level international competition.  
[Rule 44, 5.] pg 78
- All participants in the Olympic Games in whatever capacity must sign an entry form as prescribed by the IOC Executive Board.

#### IOC Rules re: Eligibility, Advertising & Demonstrations

- The IOC opposes any political or commercial abuse of sport and athletes.  
[Rule 2, 10.] pg 15
  - Eligibility for participation in the Olympic Games:
    - Comply with the Charter
    - Entered into Olympic Games by the USOC
    - Respect the spirit of fair play and non violence
    - Respect and comply with the World Anti-Doping Code

- Athlete etc may not allow person, name, picture or sports performances to be used for advertising purposes during the Olympic Games.

- The entry or participation of a competitor in the Olympic Games shall not be conditional on any financial consideration.

- Under no circumstances, throughout the duration of the Olympic Games, may any athlete, coach, official, press attaché or any other accredited participant act as a journalist or in any other media capacity

- No kind of demonstration or political, religious or racial propaganda is permitted in any Olympic sites, venues or other areas.

- No advertising on clothing worn during the Games

#### IOC Rules re: Anti-Doping

- The World Anti-Doping Code is mandatory for the whole Olympic Movement.

#### IOC Rules re: Hearings

- Any individual has the right to be heard by the IOC body competent to apply a measure or sanction to such individual. The right to be heard in the sense of this provision includes the right to be acquainted with the charges and the right to appear personally or to submit a defense in writing.
